Editorial Policies

The International Journal of Computers Communications & Control (IJCCC) follows internationally recognized standards of editorial quality, transparency, and publication ethics.

IJCCC adheres to the principles and best practices of the **Committee on Publication Ethics (COPE)**.

1. Editorial Independence

Editorial decisions are made exclusively by the Editor-in-Chief and the Editorial Board based on the scientific merit, originality, relevance, and quality of the submitted manuscripts.

Editorial decisions are made without discrimination based on race, gender, sexual orientation, religious beliefs, political views, citizenship, or institutional affiliation.

Publication fees do not influence editorial decisions.

2. Peer-Review Policy

All submitted manuscripts undergo an initial editorial screening. Manuscripts that do not fall within the scope of the journal or do not comply with the submission guidelines may be rejected prior to the peer-review process.

All manuscripts submitted to IJCCC undergo a **rigorous peer-review process**.

- The journal applies a double-blind peer-review procedure, where both authors and reviewers remain anonymous whenever possible.
- Each manuscript is reviewed by at least two independent reviewers.
- Reviewers are selected based on their expertise in the relevant field.

Reviewers are expected to adhere to high ethical standards, including confidentiality, objectivity, and disclosure of any conflicts of interest. Any suspected reviewer misconduct will be handled in accordance with COPE guidelines.

The final decision (acceptance, revision, or rejection) rests with the Editorial Board.

3. Ethical Standards and Misconduct

IJCCC does not tolerate:

- plagiarism;
- duplicate or concurrent submissions;
- data fabrication or falsification;
- inappropriate authorship practices.

All submissions are screened using plagiarism detection software.

Suspected ethical misconduct will be handled in accordance with COPE guidelines.

4. Authorship and Responsibility

All listed authors must have made a significant scientific contribution to the manuscript.

The corresponding author is responsible for:

- ensuring the accuracy of the author list;
- obtaining consent from all co-authors;
- communicating with the Editorial Office.

5. Conflicts of Interest

Authors, reviewers, and editors must disclose any potential conflicts of interest that could influence the evaluation process.

Failure to disclose conflicts of interest may result in rejection or retraction.

Undisclosed conflicts of interest discovered after publication may result in corrective actions.

Editors may request additional disclosures when deemed necessary.

6. Citation Ethics and Bibliometric Integrity

Authors are expected to cite only references that are clearly relevant and scientifically justified.

- Excessive self-citation is discouraged.
- Journal self-citation is permitted only when essential to support the contribution.

Editorial decisions are never based on citation considerations.

7. Corrections, Retractions, and Withdrawals

IJCCC reserves the right to publish: corrections, expressions of concern, retractions.

Manuscripts may be withdrawn prior to acceptance only with written justification and approval by the Editorial Board.

Allegations of ethical misconduct may be investigated even after publication, and appropriate corrective actions will be taken if necessary, in accordance with COPE recommendations.

Withdrawal requests submitted after acceptance may be subject to administrative or ethical review.

IJCCC reserves the right to withdraw the acceptance of a manuscript if authors fail to comply with post-acceptance obligations, including submission of final materials, required documentation, or payment of applicable publication fees within the specified deadlines.

8. Appeals and Complaints

Authors may appeal editorial decisions by submitting a reasoned request to the Editorial Office.

All appeals and complaints are handled objectively and confidentially, in line with COPE recommendations.

9. Use of the OJS Platform

IJCCC conducts the editorial workflow almost entirely through its **Online Journal System (OJS)**.

Authors, reviewers, and editors are expected to use the platform for all communications and submissions.
